Publicou aproximadamente 200 artigos acadêmicos e mais de 200 artigos em conferências. Conferencista em nível de doutorado, mestrado e graduação. Tem experiência comercial como analista de pesquisa operacional na indústria de petróleo e atuação em consultoria a clientes do setor público e privado. Editor associado da *Systems Research and Behavioral Science*, também faz parte do conselho consultivo / científico do *Systems and Management Sciences Journals*. Ele é Editor Associado do *Journal Operational Research Society (JORS)*.

Alberto é peruano e antes de morar na Inglaterra, trabalhou como Analista de Métodos e Analista de Pesquisa Operacional Sênior na indústria de petróleo. É professor visitante em Universidades do Peru, Argentina, Chile, México e Espanha. Foi o coordenador do projeto Euroinka (Erasmus Mundus) - 2015-2017. Entre 2015-2018 recebeu dois Projetos de bolsa de estudos *Newton Advanced da British Academy*: “Pesquisa Operacional no Brasil: Uma abordagem multimetodológica” e ‘PMEs familiares para a economia circular: capacidade de capacitação por meio da parceria México / Reino Unido. Atualmente está trabalhando com pesquisadores no Peru, Argentina, Brasil e México no desenvolvimento de modelos sistêmicos para enfrentar o impacto ambiental causado pela poluição da indústria de mineração no Peru e da indústria de petróleo no México. É membro do conselho consultivo / científico de revistas científicas e de sistemas.

He is also PI and Co-I recipient of two recent (2015-2018) British Academy’s Newton Advanced Fellowship Projects: “Operational Research in Brazil: A multi-methodological approach” (£67,770) and ‘Family SMEs for Circular Economy: Enabling capacity through Mexico/UK partnership’ NG160123. He is currently working with researchers in Peru, Argentina, Brazil and Mexico in developing systemic models to tackle the environmental impact caused by the pollution of the mining industry in Peru and oil industry in Mexico.
